



During the cottage meetings last fall, the theme of theological diversity emerged in two contradictory perceptions. One perception was that the Unitarian Society of Ridgewood's identity as a Humanist society was becoming weaker. The other was that the Society's identity as a Humanist society made it difficult for religious liberals who were not Humanists to feel fully welcome and served by the Society's ministries. My experience is that when contradictory perceptions such as these exist within a religious society, each contains some truth. Understanding what is true in this instance means, in part, having clarity on what we mean by "humanist" and what we mean by "inclusive". The meanings we give to these words can be very different.

From the Interim Minister's Mailbox The third series of "Going Deeper" discussions will focus on theological diversity. I will lay out a framework for discussion, within which you can express your understandings, concerns, and hopes. Let's explore these contradictory perceptions.

One of the attractions of Unitarian Universalism is the space it provides for religious people of diverse beliefs but shared values to explore together their beliefs and how to live their values. As you elect a Ministerial Search Committee and look to a new settled ministry to begin in the fall of 2017, you will find it helpful to have personal clarity and a common understanding of the strength of identity and breadth of diversity that already exists in the Unitarian Society of Ridgewood.

The dates for *Going Deeper into Theological Diversity* will be April 6th (Wednesday), 7 – 9 PM, April 9th (Saturday), 10 AM – 12 Noon, April 10th (Sunday), 12 Noon – 2 PM, and April 13th (Wednesday), 1 PM – 3 PM. Each discussion is free standing and open to all. As we continue our work together during this time of transition, I remind you that you may call on me regarding personal matters, the Society, and the transition. FROM THE BOARD



Dear Friends,

In this season of rebirth and renewal, the USR Annual Budget Drive provides an opportunity to pause and consider the place of our beloved community in each of our lives. Our individual pledges pay for more than 70% of USR operating costs; the remainder comes from various fundraisers, and rental and investment income.

The theme of this year's drive is **Building a Bridge to the Future**. We stand on the cusp of a new era in our congregation's 120-year history. This past year, we've begun the work of transition: we've attended Cottage Meetings and worked with our Transition Team, and we've completed our first Interim Ministry assessment. We've fielded a stellar group of congregants willing to serve on the Ministerial Search Committee. The Board will soon announce this committee to the congregation.

In the coming year, we will embark together on the search for our next settled minister. To put ourselves in the best possible position for this search, we need to shore up the footings of our bridge. Here are the items that we'll need to fund:

- <u>Continue funding our Interim Minister</u>. We are indeed fortunate to have Rev. Tony to partner with us
 in this transition period. His extensive experience, deep understanding of congregational life and social justice movements, including Black Lives Matter, sage counsel, and steady moral compass have been of tremendous value to our congregation. His salary and benefits reflect his experience and knowledge base –
 they are \$10k higher than what was budgeted for our former minister;
- <u>Prepare for the Ministerial Search</u>. Our UUA Ministerial Settlement Representative, Rev. Craig Hirschberg, estimates that we'll need \$20k to fund our search. This funding will cover travel costs for our committee members and prospective minister;
- **<u>Replenish our Building Maintenance Fund</u>**. For the last several years, the Board has dealt with shortfalls in our Annual Budget Drive by not putting into our routine Building Maintenance Fund. This is no longer an advisable course of action: this year alone, we needed to pay for a new boiler and we expect that we will soon need to fund repairs and replacements of other equipment. To help replenish the fund, we'll need \$20k; and
- <u>Continue to adhere to UUA Principles of Fair Compensation for our staff</u>. We are privileged to have such a hard-working and dedicated office staff, and we are committed to adhering to the UUA fair compensation guidelines. This year, the Board conducted an *extensive job study* for all our staff, and streamlined job descriptions and responsibilities to help ensure maximum efficiency for our staff members.

The Board made some changes in the job of the Membership Administrator, with Ann Pareti taking over Facilities Rentals. In many ways, this was fortuitous: our rental income sharply increased after Ann took over. But Ann is still a part-time employee and this change meant that she had even fewer hours to work on Membership. As a result, Ann and the other staff members too often work without compensation, in stark violation of our principles of fair compensation.

The Board is grateful to the congregation for its generosity. Because of you, we have been able to recommit to our Religious Education Program, hiring a very talented Director of Religious Education, Johanna Seale, as well as an excellent support staff. We have also continued to live out our mission of serving self and world, joining together in a myriad of activities within our congregation and in the wider world.

Now we ask that you be **ambitiously generous** -- that you dig deeper, if you can, and increase your pledge. There has never been a better time for you to recommit to our beloved community – your pledge is the cement and the pilings that will enable us to build our bridge to the future.

As always, thank you for all you do for our beloved community.

Black Lives Matter and Racial Justice in America

You can catch up on two important Black Lives Matter events if you missed them. Go to <u>uuridgewood.org</u> to listen to the podcasts of the February 21 Town Hall and/or Rev. Tony's address "Black Lives Matter" on March 13.

The next events include:

April 17 Education Justice committee service: "Why Is Your School Different Than Mine?" The guest speaker will be Junius Williams, Esq., Director of the Abbott Leadership Institute at Rutgers, Newark campus.

April 22 YWCA of Bergen County Racial Justice awards event evening at USR. The Social Responsibilities Council and Racial Justice Committee are cosponsors.

April 24 Congregation vote on hanging "Black Lives Matter" banner.

May 8 MaMa's day service sponsored by Reproductive Justice committee.

The proposed wording of the banner includes "Join the Discussion Here" and the Racial Justice committee is laying plans for Fall programs including speakers (Kenny Wiley an editor for UU World and a leader in the Black Lives Matter movement in Denver, CO), book discussions ("Just Mercy") and at least one film ("Profiled").

The number of UU congregations with Black Lives Matter banners outside their buildings continues to grow. There are now at least 135 (up 10 from a month ago). Central Unitarian Church will vote on their hanging a banner on April 24. The Congregation of the Palisades hangs their banner every Sunday in their rented quarters. April 23, 2016 Leadership Development Workshop

In an ongoing effort to foster effective leaders who can help our congregation continue to be an energetic and forceful "beacon for justice and love", the Board of Trustees and the Nominating Committee will offer another Leadership Development workshop on Saturday, April 23, beginning at 9:30am and ending with lunch, in the Fellowship Room. Coffee and Bagels will be served at 9am. The workshop is part of an ongoing effort to develop leaders of the future who will help carry on the strong tradition of lay leadership at USR. It will help congregants develop leadership skills which can help them further contribute to whatever activities they may undertake at USR or in their own lives. The workshop will provide an opportunity for personal and professional growth.

The April 23 workshop, presented as one of many under the umbrella Leadership program, "Harvest the Power", is entitled "Caring for Ourselves and Each Other". The workshop will help participants consider how they care for themselves as leaders and how they encourage self-care for congregants, as well as amongst congregants and each other. Participants will reflect on the causes of personal stress/burnout and on their own responses to stress. Among other things, participants will identify the responsibilities they hold as people and as leaders, and reflect on their sense of spiritual and emotional well being. They will also discuss differences among people in terms of fulfillment or distress, and learn strategies to build and maintain a congregational culture that encourages spiritual and emotional health in themselves as leaders, as well as in volunteers within the Congregation. "PICK 6" Yes, the Board is looking for 6 GA Delegates!! General Assembly - June 22-26 Columbus Ohio

General Assembly (GA) is the annual meeting of our Unitarian Universalist Association (UUA).

Being a delegate is a very important assignment to fulfill for USR.

The Board wants to create a fair, consistent process for the yearly selection of USR's six delegates to GA. Also, we want to provide USR with a diverse delegation to GA.

To be a delegate an individual needs to meet the following criteria:

- Be a current member of USR for two years or have been a recent member of another congregation for a minimum of two years and a member of USR for one year.
- Has been an active member. i.e. Membership, Fiber Festival, Auction, RE Teacher
- Not a 2015 delegate. This would be waived if we do not reach our delegate limit.

The selected delegates will pay for their own travel, room and food expenses. USR will pay for GA registration fee.

What is required?

- * All delegates are expected to attend all plenary sessions to be present to vote on all issues.
- * Bring back to USR information learned at sessions and workshops that would be meaningful to our congregation.
- * Write a report to record learning.

SAFE CONGREGATION



Rev. Debra Haffner, President and CEO of the Religious Institute recently informed the Safe Congregation Response Team that The Unitarian Society of Ridgewood has achieved the status as a "Sexually Safer Best Practice Congregation". This designation is based on a self-assessment and review of the USR Safe Congregation Policies. During the self - assessment phase the Board of Trustees approved some modifications to the policy including updating of the nursery staffing and child care policy, changing the requirement for 2 adults to be present as teachers/volunteers in Religious Education classes to two unrelated adults to be present at all times and guidelines for including a child or adolescent who has sexually abused.

With this designation, congregations strive to sustain a community where practices and procedures serve to ensure all members, friends, adults, children and youth are treated with respect and protected from harassment and abuse. It allows USR to use the seal in all communication venues until 2020 when it must be renewed.

This designation has recently been offered by the Religious Institute (RI). RI is a multifaith organization dedicated to advocating for sexual health, education and justice in faith communities and society. It was founded by Rev. Haffner, a UU minister. USR is one of the first congregations to be given this designation.



Wow, thank you and congratulations! You, the members the USR, raised a total of \$1,655.00 for the Advocates for Children. We gave from the special collection offering plate \$1,155; plus one member sent directly to ACNJ a \$500 donation. ACNJ, nonpartisan and not-for-profit, provides research, information and advocacy for legislative and systems change on behalf of vulnerable children so that they may live in a safe, healthy, community that educates, values and nurtures them. ACNJ's mission and work fully align with our congregation's commitment to "Black Lives Matter" as well as reproductive justice. I applaud all the members of the congregation that helped provide this investment in justice for children in NJ. Plate Collections

Once a month the USR plate collection is donated to a particular cause or organization nominated by members of the congregation and voted by the Social Responsibilities Council. This month's collection on April 3rd will go to the Delaware Highlands Conservancy, a nonprofit land trust in the Upper Delaware River region. The Conservancy works with landowners and communities to protect clean water, working farms and forests, and wildlife habitat throughout the region so vital to those living downstream as well. They host a number of educational events throughout the year, including the popular Eagle Watch bus tours, as well as workshops for landowners to learn about stewardship of their lands. A Celebration to honor the Life of Tyler Clementi

In 2009, the USR Board granted the Social Responsibilities Council (SRC) approval to use the Offertory Collection at Sunday services to collect money for social justice causes, as determined by the SRC. Since then, the congregation has responded generously. During the 2014-15 congregational year we donated \$13,441.00 to 14 plate collections.

The cause should be consistent with the mission of USR to be "a beacon of justice and love in the world". This Society is an <u>anti-racist congregation</u> committed to reflecting this commitment in the life and culture of the entire organization. Adopted May, 2002.


