Brief Realm Instructions

- To log on the first time: You should have received an email invitation to Realm. Use the link in the email to set up a password. Or, use the Realm link on the USR webpage. From the Realm logon window enter your email and click Forgot Password. This will allow you to set up a password.
- Once you have a password: From the initial window, click your name in the upper right corner. From the list that appears choose "MY PROFILE". From here you can upload a photo (by clicking on the square where your photo should be) and then click EDIT PROFILE. When editing your profile remember to update both sections, CONTACT INFO and PERSONAL INFO.

Family Promise




"Give Us The Ballot: The Modern Struggle for Voting Rights in America" - March 4, 2020

March 22nd Sunday Service

The Reproductive Justice Committee is pleased to announce the March 22 service. Gaby Garcia-Vera, the States Program Manager at Catholics for Choice (CFC), will be our guest speaker. The title of his address is "Compassion and Conscience: Abortion in Good Faith."

Gaby coordinates CFC's strategic engagement at the state and local level. Working with prochoice Catholic policymakers, state partners and activists, Gaby engages, educates and mobilizes people across the United States to advance sexual and reproductive rights. He employs his wealth of experience forging and sustaining coalitions, mobilizing grassroots activists and engaging state policymakers to deliver analysis and develop and implement CFC's Domestic State Program through statements, positions and resources that make the moral case for abortion rights and access.

At 12 noon, the Reproductive Justice Committee will be offering a panel to further explore reproductive health issues.

Save the Date - Panel Discussion: Sunday, March 22, 12 noon

The Reproductive Justice Committee invites you to a panel discussion, "Reproductive Rights: Abortion Care and Access 2020 -- Facts and Messaging."

Support for legal abortion is the highest it has been in the last two decades. At the same time, abortion bans are passing in some states, proactive legislation is being enacted in others, and court cases are making their way to a Supreme Court hostile for abortion rights. The speakers will address this political landscape with special emphasis on the need to solidify abortion access in NJ. In addition, the full spectrum of abortion care will be described. The speakers will also guide us to explore, understand and then articulate our own values about reproductive rights.

Presenters will be Noa'a Shimoni, M.D., M.P.H Associate Professor and Interim Chair, Department of Family Medicine Director, Student Health Services at Rutgers Health Sciences Campus at Newark; **Sarah Best**, Legislative and Political Manager Planned Parenthood of Northern, Central and Southern NJ and Planned Parenthood Action Fund of NJ; **Gaby Garcia-Vera**, Domestic States Program Manager at Catholics for Choice.

When he crossed the Texas border, he was detained, April 2019 until his release on parole September 2020 from the Essex County Jail and is desperate to find housing here. His English is limited. He is willing to work any job.

A letter from Immigration Task Force

Ira,

In 2018, New Jersey launched a new, publicly funded legal defense program for individuals who are detained and facing deportation in New Jersey; this effort is called "Universal Representation."

Because of that effort -- strongly supported by UUs across NJ via our Immigration Justice Task Force -- hundreds of families will be able to remain together, and more immigrants languishing now in New Jersey jails and detention centers will be able to plead their case with a competent lawyer by their side.

However, the current funding of \$3.1 million only covers a fraction of the thousands of indigent immigrants who remain behind bars, facing not only deportation but the loss of their livelihoods and their families falling deeper into poverty and despair. Right here in the Garden State.

We need NJ's legislature and administration to reaffirm their investment in keeping families together and fighting back against a nationally-coordinated, politically cynical attack on our immigrant brothers and sisters.

How? By continuing to increase funding levels in the next state budget so the Universal Representation program can succeed at a moment in our nation's and state's history when it is needed most.

This coming Tuesday, February 25 the NJ Governor will unveil his annual budget. It is critical that as many Unitarian Universalists and our allies reach out to Governor Murphy's office to urge him to allocate the (relatively) small amount of an additional \$9-10 million dollars to the Deportation Defense Fund (Universal Representation).
