August 2019 Plate Collection for Table to Table

Table to Table is Northeast New Jersey's first and only food rescue program. Their mission is to redistribute free of charge fresh, wholesome food which would otherwise be wasted. By operating a local fleet of refrigerated trucks they're on call to pick-up fresh food from supermarkets, caterers, corporate cafeterias, and restaurants. This food is then delivered free of charge to over 170 recipient non-profit agencies such as soup kitchens, safe houses for abused women and children, homeless shelters, veterans and elder care programs. Table to Table's fundraising and management expenses don't exceed 2.5%, which has earned it Charity Navigator's highest 4-star rating for 8 years in a row.

SHARE would like to thank the Unitarian Society of Ridgewood's endowment fund for its generous grant of \$2500 to help replenish the Ritter Fund. The Ritter Fund was established to honor two special USR congregants and leaders, June and Jack Ritter, who helped organize the shared housing concept in Ridgewood. The Ritter Fund helps seniors who reside in one of the SHARE houses who, through circumstances not of their making, can no longer meet the cost of living expenses.

SHARE has long and deep connections to our congregation and is one of the few affordable housing opportunities for independent seniors in our area. Each resident has their own room but shares provided meals and has the opportunity to socialize and participate in activities and companionship with other people. Protect Abortion Workers and Patients

News from UU Faith Action NJ concerning a bill signed into law to protect abortion clinic workers and patients, sex abuse and stalking victims.

TRENTON, NJ (July 19, 2019) – Earlier today, Governor Murphy signed legislation, S1761, to expand New Jersey's Address Confidentiality Program to include victims of sexual assault and stalking, and reproductive health care workers and patients. The expanded program will thwart abusers and harassers from finding individuals at home, work, and school. The bill unanimously passed the Senate by a 37-0-0 vote and the Assembly by a 75-0-0 vote. Now law, this bill was hailed by advocates as a necessary measure to protect victims of abuse and reproductive health care patients and workers amidst a toxic political landscape and national attacks on abortion clinics and providers.

"UU Faith Action NJ thanks Governor Murphy for signing into law the Address Confidentiality bill," said Rev. Rob Gregson, Executive Director of Unitarian Universalist FaithAction New Jersey. "As people of faith working for a more just and caring world, we are grateful to the Governor and Legislature for helping to empower reproductive health care workers including, doctors, nurses, staff and volunteers who work so hard to guarantee people the right to access the health care they need, often under very difficult circumstances. Allowing staff as well as patients the ability to protect their identity in the face of today's local and national anti-abortion campaign helps to give patients and clinic workers a level of safety and security so they can continue to give and receive the best reproductive health care possible."

The law, modeled after California's "Safe at Home" program, helps those who fear for their safety keep their home address confidential. Participants and survivors in the program are assigned a substitute address by government agencies in lieu of their actual residential or mailing address. The participant's actual address remains confidential and available only to government program staff and law enforcement.

Due to anti-abortion rhetoric amplified by the Trump administration and the alarming number of state laws restricting or banning abortion care, anti-abortion extremists are feeling emboldened to harass and intimidate clinic staff and clients.

"As independent abortion providers who have served as a trusted resource for New Jersey families since Roe v. Wade, we extend our gratitude to Governor Murphy for signing these common-sense protections for our health care workers and community members into law," said Roxanne Sutocky, Director of Community Engagement for Cherry Hill Women's Center and steering committee member of the Right to Thrive NJ coalition. "Cherry Hill Women's Center provides indispensable health care services, and we should not be compromised by those who continue to target abortion providers and perpetuate acts of harassment, intimation, and violence with increasing frequency nationwide. Health care workers and those accessing vital reproductive health care services, including abortion care, should not have to be subjected to stalking or office invasions. We applaud this important legislation, that assures that when we need to make criminal reports of these actions, law enforcement is able to protect our identity as victims of anti-abortion extremists."

Abortion clinics nationwide faced a record number of picketing and trespassing incidents in 2018. Clinics and staff also faced increased rates of obstruction, vandalism, and online hate speech, according to the latest National Abortion Federation Violence and Disruption report. In the past year along, New Jersey abortion clinics have reported four invasions.

"Patient and staff safety is our top priority at Planned Parenthood," said Kaitlyn Wojtowicz, Legislative and Political Director of Planned Parenthood Action Fund of New Jersey and steering committee member of the Right to Thrive NJ coalition. "We commend the sponsors of this bill and Governor Murphy for helping to ensure that all patients can access the reproductive health care they need – and that clinicians can provide that care – while feeling safe and supported."

"Today, New Jersey has added an extra layer of protection for survivors of sexual violence by ensuring they have access to the Address Confidentiality Program," said Patricia Teffenhart, executive director of the New Jersey Coalition Against Sexual Assault. "The FBI recognizes sexual assault as the second most violent crime, the traumatic impact of which lasts a lifetime. New Jersey has a growing portfolio of policies designed to address the needs of victims/survivors in the aftermath of victimization, and expanding access to the existing Address Confidentiality Program is the next logical step in our continued pursuit of trauma-informed, survivor-centered policies that support those impacted by this heinous crime. We offer our appreciation and congratulations to the allies and stakeholders who worked to make this a reality."

The current Address Confidentiality Program serves approximately 270 adults and over 400 children, according to the latest data from FY2016. The program is administered in the Division on Women in the Department of Children and Families.

Northern NJ Sanctuary Coalition

The Northern New Jersey Sanctuary Coalition is looking for a host family or individual with at least one Spanish speaker, for PR, a 21-year-old asylum seeker from Mexico, reared in extreme poverty, who was horrendously abused and quite severely traumatized by an older brother he began living with at age 13. He has a lawyer who has helped him apply for asylum. He has recently received working papers and NY Medicaid, was released from detention in the Bergen County jail in August 2018, then lived in a shelter, where he was again traumatized, and is now in temporary housing at the Seafarer's Inn in Union Square, NYC. He is desperately in need of housing and wants to work. He speaks no English but wants to learn and has education only through the 2nd year of secondary school, and little work experience.

JDN is a 32-year old asylum seeker from Rawanda, who was a leader of an LGBTQ organization. He has a university education and is proficient in English and French. In Rawanda, he was employed at the Water and Sanitation Corporation, where he delegated water apportioning. Prior to that, he worked as a plumber. Because of his position as a leader for an LGBTQ advocacy group, he faced persistent persecution at home. After arrival in the U.S., he was detained in the Buffalo Federal Detention Facility, but after 2 months was released on a bond of \$10,000, paid for by the Brooklyn Community Bail Fund. He would like to live in the NY/NJ area and his attorney, who is affiliated with the NY Immigrant Family Unity Project, is soon to submit his asylum application. Once he locates stable housing in the area, his case can be moved to immigration court in NYC.

Solitary/Isolated Confinement Bill signed into Law!

Our membership with UU Faith Action NJ has made an impact in our state. A few years ago our congregation members were provided with the opportunity to sit in a solitary confinement cell and experience this isolation. We received the following information from UU Faith Action and should celebrate the work that has been done to create this change. When you sign letters and make phone calls, you become a part of the change and make the difference for justice. When we work together, this is what we can accomplish! Kudos to all of you! We hope you will feel the pride we do in being able to work together for social justice.

After Many Long Years of Struggle, NJ Finally Moves Away from Solitary/Isolated Confinement for People in Our Prisons.

WE DID IT!! Isolated/Solitary Confinement as we know it in NJ and across the U.S. has been fundamentally changed for the better. *Real human lives will be directly affected.* Many, many people will now have an increased chance of returning to their families and neighborhoods without the additional trauma of isolated confinement added to their list of struggles to overcome.



It feels very, very good to be able to write those words.

At long last, one of the most progressive and far reaching reforms *in the nation* of our far-too-punitive penal system was signed into law yesterday, July 11th, by Gov. Murphy.

Isolated/solitary confinement (a replica cell built by folks at Central Unitarian Paramus is shown on the left), while not banned outright, now comes with safeguards and oversight that will--with our continued monitoring and advocacy--end the worst kinds of abuse and outright torture too long practiced in the jails and prisons of NJ.

This is a special love letter. It is for all of you who have worked so long and so hard over many years (since at least 2013/2014 during the Christie administration) to help make this historic moment possible. (*Like those from FUUFHC and UUCP attending a solitary confinement hearing in renton in the picture below.)*

A special shout out to the chair of our Criminal Justice Task Force, **Susan MacDonnell** (UU Princeton) and

"special UU envoy" to NJ CAIC, **Tricia Idro-bo** (Beacon UU Summit) as well as to my predecessor in this post, **Rev. Craig Hirshberg**. Without their willingness to write many emails, and attend many rallies and meetings, UUs across NJ would never have been such an integral part of this important victory.

Public Comment Requested concerning New Asylum Policy

Enforcement of Asylum Rule will virtually end Asylum at the border: SUBMIT PUBLIC COMMENT!*

The Department of Homeland Security has proposed an interim rule, effective Tuesday, July 16, 2019, that would bar migrants coming to the U.S. southern border from seeking Asylum unless they applied for Asylum in a third country and were denied.

The <u>new interim rule</u> is deliberately being used and enforced through an eligibility and procedural modification. The implications of enforcing this rule will have long standing consequences, set the precedent that it is illegal to apply for asylum and further separate immigrants from the dignity they deserve. In order for migrants at the border to apply for asylum, they must:

1. Have applied for asylum in any country they passed through during their migration and were denied asylum status.

OR

Be a victim of human trafficking.

OR

3. Have traveled through a country that did not sign one of the major refugee treaties.

This interim rule leaves little opportunity for migrants to receive asylum status, forcing them to return to the conditions they are fleeing from. We cannot allow the continual criminalization of immigrants seeking refuge in the United States.

The ACLU has deemed this rule illegal and has since filed a lawsuit against the Trump administration. Currently, the Department of Homeland Security is accepting public comment. Click here to submit your comment!

Sample Script:

Dear Sir/Madam:

I/We strongly oppose the proposed changes to the Asylum Eligibility and Procedural Modifications, which, as we know from our years of experience [in immigration law and training immigration professionals on complex legal matters] [as an advocate for the immigrant community] will cause uncertainty, inconsistency, and chaos for the thousands of migrants who take the dangerous journey to the U.S.This stands in stark contrast to our country's commitment to liberty, the pursuit of happiness and facilitating the inclusion and integration of immigrants into the United States.


