UUA General Assembly (GA) Delegates Wanted

It is time again to think about GA, the annual meeting of the Unitarian Universalist Association (UUA), where attendees worship, witness, learn, connect, and make policy for the Association through democratic process. This year, GA is in Spokane Washington, June 19-23.

The theme is The Power of We. In a time of great challenge and heartbreak in our world, what does our faith demand from us? At this year's General Assembly, we will explore the power, possibility, purpose, struggle and joy of finding the path forward together as Unitarian Universalists. Attendees will leave inspired, with the tools needed to carry on the work into their own congregations and communities. Join us as we work for collective liberation inside and outside our faith.

So far USR has one delegate attending. We would like to have a few more delegates. Delegates can go to Spokane and are responsible for their own transportation, housing, food and registration costs. Another option is to be an off-site delegate and just be responsible for the off-site registration cost, which is less than the on-site registration cost. Off-site delegates would attend meetings and seminars, which are live streamed, from the comfort of their home or any location they choose. Off-site delegates can make motions, ask questions and vote on issues important to the UUA. It's really neat the way it works. Annual Meeting June 9th

Here at USR we pride ourselves on our strong traditions of lay leadership and transparent governance. This means that we show up.

On June 9th an important vote will be held to streamline our governance structure. In order for this change to be made we need a special quorum of 33% of our membership to be present to vote.

At the Annual Meeting taking place on June 9th following the service, the congregation will vote on the Budget, a By-Law change to adjust the number of members of the Board of Trustees from 9-7, and the proposed slates of Board of Trustees and the Nominating Committee. In order to pass a By-Law Change, at least 1/3 of the 246 members of the congregation, which is 82, must be present, so please attend this very important meeting and participate in the democracy of our congregation.

Annual Meeting: June 9th after the Service: Listen, be heard, VOTE.

PROPOSED CHANGE TO ARTICLE V – BOARD OF TRUSTEES

Section 1

The governing body of the Society shall be a Board of Trustees consisting of nine (9) seven (7) voting members of the Society who are elected by the membership at the Annual Meeting by a majority of the votes cast. The minister shall serve as an ex-officio, non-voting member of the Board. To serve on the Board, a person must be a member of the Society.

The Board shall consist of the (4) officers - President, Vice President, Secretary, and Treasurer, (5) (3) Trustees and the minister. The Officers shall serve a (2) year term with the Secretary and Treasurer having the option of no more than two (2) additional years. The five (5) three (3) Trustees shall serve a term of three (3) years.

The Vice-President shall also serve as the chair of the Leadership Program Council until such time as she/he becomes President and at that time the new Vice-President shall assume that position.

Resignations of Officers or Trustees must be tendered in writing. In the event of a vacancy on the Board of Trustees, the President, with the approval of the Board of Trustees, shall be empowered to appoint a successor to serve until the next Annual Meeting.

REPRODIJICTIVE JUSTICE

From the Reproductive Justice Committee

People have been asking what the UUA is doing about the current attack of reproductive health including abortion that is occurring in this country. Below is a very strong statement from the UUA President, Susan Frederick-Gray. As she notes, this is based on the Statement of Conscience that was the culmination of the Congregational Study Action issue which was offered to General Assembly by USR in 2012. This is a very precarious time, and we are pleased to have the UUA standing with us.

Address Confidentiality Bill Expansion May 23, 2019 Update

The UU Faith Action NJ Reproductive Justice Task Force submitted a suggestion for a bill to Sen. Loretta Weinberg in 2017. The members of the task force had become increasingly concerned about the harassment, intimidation and barely veiled violence that reproductive health care clinic workers, volunteers and patients were facing. After reading "Living in the Crosshairs, The Untold Stories of Anti-Abortion Terrorism" by David S. Cohen and Krysten Connon, and learning that California had a law that allowed these people to keep their addresses confidential, it appeared like a good idea to explore this for NJ.

The Legal Advocacy Task Force of UUFANJ researched this issue and developed proposed legislation to share with Sen. Weinberg. The new address confidentiality bill would expand the address confidentiality law in place for domestic violence survivors to include reproductive health workers. The bill was introduced in the State Senate in May 2017. Since that time it was:

- Passed in the State Senate
- Reintroduced into the 2018-2019 Senate legislative session
- Introduced into the 2018-2019 Assembly legislative session with Assemblywoman Pam Lampitt chief sponsor
- It has passed the State Senate
- Recently the bill was merged with another address confidentiality expansion bill to include sex abuse and stalking victims with Assemblywoman Pintor Marin chief sponsor.

On Thursday, May 23 the bill passed in the State Assembly. It is now headed to the Senate for concurrence with the merger. If it passes then, it will go to the Governor's desk for signing.

During the stressful/challenging time for abortion rights advocates, it is notable that this bill has passed both houses with unanimous votes. As abortion bans are in place and harassment increases at clinics, this law will give clinic workers, volunteers and patients a sense of safety and security.

ENVIRONMENTAL JUSTICE COMMITTEE SEEKS GREEN COMMITMENT



At the Annual Meeting on June 9, 2019 the congregation will be asked to vote on a statement of conscience from the Environmental Justice Committee affirming our commitment as a green congregation. See below.

Why are we doing this?

- Climate change is threatening our planet for ourselves and for future generations. It is urgent that we take a public stand for climate justice and pledge to preserve and protect the environment.
- Like other USR statements of conscience on racial justice and welcoming it defines our congregation as committed to fully explore and deepen our dedication to our principals, for us, the seventh principal to respect and care for our earth.
- The mission of our committee is to learn, lead and empower our congregation to be better stewards of the earth as well as seek more equitable policies for all people. Through the affirmation we are asking that we join together as a congregation to commit to employing green practices both at USR and as individuals. We also seek a commitment to justice for those who bear some of the most potent effects of environmental degradation.
- The affirmation as a "green congregation" is a broad, general, over-arching position statement that we, as a congregation, support the environment.

The effects of the vote will guide the Board, Minister and administration in making future environmentally sound decisions.

<u>Unitarian Society of Ridgewood Affirmation as a Green Congregation</u>

BECAUSE we affirm justice, equity and compassion in human relations, the inherent worth and dignity of every person, and respect for the interdependent web of all existence of which we are a part; and because we share the goal of world community with peace, liberty, and justice for all; and

BECAUSE the concept of protecting the Environment of the Earth links the principles of liberal religion with the values of ecological awareness and racial and class justice, and

BECAUSE we support the free and responsible search for truth and meaning, and we recognize that the overwhelming consensus within the scientific community is that global climate change is real, and that the activities of humans are at least partially responsible, and

BECAUSE, global climate change seems to be producing an extinction event in nature, and over time, could potentially threaten all life on earth,

NOW, THEREFORE, WE, the Congregation of the Unitarian Society of Ridgewood, hereby AF-FIRM and DECLARE that:

We support sustaining the climate so that planet Earth will remain habitable,

We support and commit to the ongoing greening of USR as steps leading toward our long-term goal of Certification of USR as a Green Sanctuary,

We affirm ourselves as a Green Congregation, signifying our ongoing commitment to environmental justice, and to preserving, protecting and defending the Environment for all.
