Unitarian Universalism and Social Justice: How we "Walk the Walk" Who, What, Where,

We have a UU alphabet soup of organizations. What you should know: a basic primer.

SRC of USR: The Social Responsibilities Council of the Unitarian Society of Ridgewood is our local congregation's social justice committee, organizing and coordinating all our social justice work. We currently have six operating groups, Reproductive Justice, Environmental Justice, Homeless and Hunger Issues, Living the Welcoming, Peace and Justice, and Racial Justice. These groups participate in local events regarding social justice issues like Martin Luther King Jr. Day celebrations, environmental fairs, public demonstrations and other UU congregations' events. They also prepare letters and petitions for our congregation to sign, and hold events that are open to the general public and are publicized in the local media. The task groups can become dormant or new groups formed as needed and interests change. Information about each group and upcoming events is available every Sunday at coffee hour at the SRC table and in our eblasts and newsletter. This work is supported by your contributions to USR and has only you to rely on to pay the bills and do the work.

<u>UUFANJ:</u> The newest UU organization for us here in New Jersey, Unitarian Universalist Faith Action New Jersey (previously called The UU legislative Ministry of New Jersey) was established almost 10 years ago and is based in Summit, NJ. It employs a full-time executive director and a part-time administrator and relies heavily on volunteers to get the work done. UUFANJ is our UU face in New Jersey and from its inception, has been a major force for legislative reform in our state. As the name implies, it works to promote UU values in our New Jersey laws. Through them we have been successful in making changes in the way New Jersey works, from enlisting our state representatives to support marriage equality to protecting the rights of youth in detention, UUFANJ has been a successful force for change in our state. There are two statewide meetings each year to gauge the work being done and to plan the ongoing strategies. They are open to anyone interested in being involved directly or who just would like to be informed about the issues. Working groups currently focus on economic justice/ housing, reproductive justice, gun violence prevention, environmental justice, criminal justice reform and immigration reform. This last area has been a primary focus due to the current political atmosphere and, through the efforts and under the supervision of one of the Board members, a Legal Assistance Program is being established. Consisting of a group of leading immigration law firms, the program will provide low cost legal assistance to people in detention. New groups are formed and old ones discontinued as interest or need changes. UUFANJ is funded in two ways. Congregations are encouraged to support the organization through a voluntary dues program paid by the member congregation based on their size, and at whatever level is financially possible for it. USR is a contributing member but UUFANJ needs more funds than what the member congregations contribute to continue its work, particularly, to help fund the new legal assistance program. This need is filled by individual members who make donations, which are tax deductible. UUFANJ also welcomes new additions to their working task forces.

<u>UUSC:</u> The Unitarian Universalist Service Committee, based in Cambridge, MA, has been in existence since shortly after the Second World War. It was established to provide international assistance to people in need whether because of natural disasters like famine or floods, or due to human causes like war or persecution. Working with other organizations, they provide on the ground help, direction and money to aid in relief efforts which can go on for years. Their work promotes our UU values and UUSC is the largest public face of UUs around the world. UUSC is funded solely by individual members and gets no monies from congregations. You can be a supporting member. Contributions are tax deductible.

<u>UU, UNO:</u> The Unitarian Universalist, United Nations Office, based in Boston, MA, is another independent UU organization. They maintain staff and contact at the United Nations offices and work to promote UU values in UN programs particularly in situations where people are oppressed or require aid. UU, UNO does not get institutional support from any other organizations and depends on individual UU donations to fund their work. You are their source of support and can sign up to be a member. Contributions are tax deductible.

<u>UUA:</u> The Unitarian Universalist Association, headquartered in Boston, MA, is a national organization serving member congregations in the US. Individuals are not members, only congregations. Membership is not required but if the congregation is a member, it pays dues to the UUA based on the number of individual members in the congregation. USR is a member. UUA holds an annual meeting, General Assembly (GA), for representatives of all their member congregations with workshops on every conceivable issue related to UU including social justice, RE, general philosophy, organizational structure, finance, etc. It also provides focused social justice issues with resources for individual congregations to use. Our own Racial Justice Committee program utilizes this resource. The UUA sometimes partners with UUSC or UU, UNO for emergency situations. The president of UUA and the board can advocate for social justice issues based on the positions taken at General Assembly and based on UU principles.

If you're interested in a particular area or want more information, just stop by the Social Responsibilities Table at coffee hour. The work is never finished!

September Plate Collection

The September plate collection will be shared with HealingSPACE (formerly Rape Crisis Center), of the YWCA/ Bergen County. The mission of HealingSPACE is to empower survivors of all forms of sexual violence through support, advocacy, counseling and resources necessary to lay the foundation for the healing process and to prevent sexual violence through education, training and awareness to create a safe community for all. The center is Bergen County's only Sexual Violence Resource Center. It is a safe and welcoming place for survivors of sexual violence and their loved ones. Their 24/7 crisis intervention hotline (201-487-2227) and online chat provide free and confidential assistance. Support is available to anyone who has been affected by sexual violence, whether it happened hours or years ago. The program director will speak to the congregation on **September 15**.



The Racial Justice committee will meet on Wednesday, **September 5th** at 7 p.m. in the Reeb conference room. Lois Parker-Hennion, a member of the committee and member of the 2017 team of educators selected by the Southern Poverty Law Center's Teaching Tolerance initiative, has offered to tell us what she's learned about racism in the United States the last two years and their efforts to bring this into the country's classrooms. The Reproductive Justice Committee invites you to join them for their first meeting of the 2018-2019 congregational year on Sunday, **September 16** at 11:30 a.m. in the Reeb Conference Room. We will be discussing programming for 2018-19. There are many reproductive justice issues that the committee has been watching including, but not limited to the following: maternal/infant mortality rates, especially for people of color and possible direction to legislate change in NJ; issues for women in Edna Mahan Correctional Facility for Women including sexual assault by corrections officers, use of shackles during pregnancy, labor and delivery, current and menstrual products for the incarcerated, poor, homeless and in schools. In addition, in this political climate we will be opposing the nomination of Brett Kavanaugh to the SCOTUS as well as tracking the many court case rulings both at the federal and district levels and the administration directives. Currently Title X funds are being threatened for Planned Parenthood and other clinics that offer full range reproductive health. There is a strong need for advocacy. We are also exploring events to discuss population control and eugenics. There is lots of work to be done. We will be setting priorities at this meeting. Please join us!

GET OUT THE VOTE

The Social Responsibilities Council is committed to a GOTV campaign between now and the election on Tuesday, **November 5, 2018**. The SRC table will have applications to register to vote and Applications to Vote by Mail at the SRC table all Fall.

As we all know, one of the major obligations of citizenship is to vote. You must be 18 years old to vote. You can register when you are 17 years old if you will be 18 on voting day. You must also be a resident of the county for at least 30 days before the election. The deadline to register to vote for the November election is October 16, 2018.


